	REGISTRATION FEES			
Official and Athletes Registration Fees	The total amount of USD 720 for each person for the duration of 6 nights stay in a twin-bedded sharing room. This fee includes hotel accommodation, 3 meals per day, shuttle to and from the airport to the hotel and to competition venue and farewell party. The price of the double rooms (USD 720 /6 nights per person x 2 persons= USD1440.00. Single room price USD 1000 for 6 nights. These prices are available for the officials and delegates as well. It is compulsory to pay 100 \$ per person as a hotel security deposit at the time of registration. The same will be refunded only after deducting any damages in the hotels, rooms, auditorium or any other places.			
IMPORTANT NOTICE				
Please note it is compulsory for all the participating athletes, official and judges must stay in the official hotel provided by the organisers. Those who do not stay in the official hotel will not be allowed to participate in the said championship.				
WBPF Executive Committee:	WBPF Executive Committee members are exempted from paying the Registration Fees, including Patrons and Honorary Life Members. WBPF Executive Committee Members are allowed to be accompanied by their spouse only. Their accommodation, Meals, etc. are on gratis. Standing Committee Members with the exception of the Chairman and Secretary of each Sub Committee may have to share a twin sharing room. If a Sub Committee Member requests a single room, he/she must pay the difference of USD 500.00 for a single room for the duration of 6 nights.

Extra	Officials

Any judges, coaches or trainers who are not officially participating as an Athletes or Delegates will be responsible for all of their own expenses. Only those whose names are officially recommended in the official entry form by the respective national federation will be allowed to participate as an athlete, official, judge and supporter of that respective country. This rule is also applicable for the family members.

WEIGH-IN AND REGISTRATION

Registration for athletes and Weigh-in will take place at Hotel Uzbekistan (please refer to the day-to-day program) for full details. It is the responsibility of the Chief Delegate or Team Manager to make sure that all athletes are on time for the Weigh-in and Registration. If an athlete is late for the Weigh-in and Registration, that athlete will be disqualified and will have to pay all of his own expenses.

JUDGES

In order to assist the WBPF Judges Committee in their selection of judges for this Championship, please forward your nomination for Judges from your National Federation as soon as possible but no later than 10th September, 2021. Judges must possess an International/Continental recognized judge's card and must produce to the Judges Committee. IMPORTANT NOTICE

- Each athlete and the official who wish to participate in the said championship must stay at the official hotel by paying the requisite Registration Fees. Those who bypass the rules and book directly with the hotel will not be eligible to participate in the said championship, attend all the functions (breakfast, lunch and dinner) including entry into the competition venue. No I.D. cards will be issued. They will not be picked at the airport to the hotel vis a vis for departure as well.
- Each athlete must bring his/her passport and posing music to the weigh-in and registration, failing which the athlete weigh-in will not be processed.
- No G-string bikinis are allowed. An athlete must comply with specification sheet attached and
 they must produce their bikinis for verification and approval for the pre-judging and finals at the
 weigh-in area. The bikinis will be stamped with a marker as an approval by the Judges Committee.
- During the weigh-in, all female athletes should be properly dressed. NO PYJAMAS OR NIGHT GOWNS are allowed. This is to protect the image of our sport in the event press or VIPs were to be present during the weigh-in, it will put our sport in an awkward position. Please use track suits or a decent dress/jeans.
- At the parade of the nations, if you were to allocate female athletes, she should also appear in a track suit and not in a bikini.
- All female athletes are to be reminded that they are participating in a sporting event and not in entertainment venues like night clubs, therefore, we should ask the women to change their behaviour when they come on to the stage in the "walk-in" wiggling their rear ends or looking back into the audience when they stand in the quarter turn facing the back of the stage and stretching out their butt and winking at the judges and the audience. This is not a sports presentation and it will be seen as sexual harassment to the public.

Kindly nominate the name of your judges in advance; last minute submission will be rejected. All judges should use a grey suit with the official logo of WBPF/WBPF and female judges with a grey blazer with a grey skirt or dress pants.

Entry Pass Card	Entry Pass will be issued to the Weigh-in and backstage area during the Weigh-in, Pre-judging and Finals. It will be distributed at the Judges/Team Managers Meeting as follows: Five (5) or more competitor – Two (2) Passes will be issued and less than five (5) competitors, one (1) Entrance Pass will be given.
Media Accreditation	All media accreditation, except local media, shall be controlled by the WBPF. All persons wishing to obtain media accreditation for this event must register with the WBPF by completing and signing the WBPF Media Accreditation Form. The form must be submitted to the WBPF by email at wbpsf.ckam@yahoo.com , and wbpfsecgeneral@gmail.com
Athletes without Delegates	All athletes competing at WBPF Championships must be members in good standing of their National Federations. Any athlete who arrives without a delegate must carry on the official letter of Authorization of Participation from his/her National Federation, failing which the athletes will not be eligible to participate.
Failure to Honour Final Entry Form Deadline.	Deadlines are set to assist the Organizer with arranging accommodations, meal, onsite transportation and other Championship's activities. A failure to respect these deadlines is a breach of the WBPF rules. If a National Federation fails to respect the deadline written on the Final Entry Form, each "Official Participant" from that federation will be required to pay all of his or her own expenses, including accommodations, meals, onsite transportation, and access to the Pre-judging, Finals and Farewell Banquet.
Misrepresentation	Misrepresentation is a serious breach of the WBPF Code of Ethics and occurs when an "Official" of a National Federation deliberately misrepresents the number of Athletes and Delegates so as to obtain free-of-charge accommodations, meals, onsite transportation, and access to the prejudging. Finals and farewell Banquet, and other amenities at the expense of the organizer. Part of this misrepresentation may be a false claim that a person is an Athlete only to have that so-called athlete fail to officially register as a competitor at the Weigh-In or, once having officially.
Medical Withdrawal	Once officially registered, no Athlete may withdraw from the competition, without the prior approval of the WBPF Judges Chairman, who has the right to verify the reason for the withdrawal. Any National Federation that fails to seek the prior approval of the WBPF Judges Chairman before withdrawing an athlete shall, for that athlete's non-participation, is fined an amount equal to the Special Package Rate.

Visa	Please note that the Organizer will not be able to provide landed visa to any country. Therefore, please consult the Uzbekistan Embassy in your country to determine if you need a visa. Upon request, an official invitation letter shall be signed and issued by the Organizer. It is to be noted that the Visa Administration process differs from country to country and hence kindly apply well in advance.

Language	The official language in Uzbekistan is standard Turkic . English is spoken in hotels and some restaurants		
Doping	Doping will be conducted by the WBPF Anti-Doping Committee.		
National Anthem/National Flag	 a) You must provide Two (2) National Flags of your country. The flags must be manufactured of dense silk and must measure no more than 2.5 meters x 1.5 meters. You may also provide the digital National Flag on Pen drive. b) You must also provide your National Anthem (shortened version) on Pen drive / CD. Video or cassette not acceptable. 		
Posing Music	Posing music must be on Pen drive/ CD only and produced with good quality. The music should be cued from the start of the Pen drive/CD. Each competitor must affix his/her name on the Pen drive/CD for easy identification. The USE OF PROFANE, VULGAR OR OFFENSIVE LANGUAGE IN POSING MUSIC IS PROHIBITED.

PARTICIPATION RULES

Country with less than Two (2) Competitors – Only one (1) Official will be allowed to pay the official registration fee

A country with Three (3) and above competitors – Two (2) Officials will be allowed to pay the official registration fee

A country participating with woman athletes may send One (1) extra female official and she needs to pay only the official registration fee

Official or any other guests requesting for a single room have to pay the differences levied by the organizer based on the supporter's rates published herein.

One judge per country will be allowed on gratis (No registration fee to pay) however, the judge must share a twin bedroom with other judges or officials.

However, country participating with woman athlete may send 1 (one) extra female judge and no need to pay the registration fee as well but need to share a twin bedroom with another official of the same gender. If more than 2 (two) judge is nominated, he or she has to pay the registration fee, however, a country will be limited to enter two extra judges only, including one female judge to enjoy this privilege on sharing a twin room. A maximum number of judges should be 3 (three) only. All other extra judges will have to pay the supporters fee in full.

A country that exceeds the above quota will have to pay for their official and supporters fees.
